The Board of Managers of the Greater Seymour Trust Fund is pleased to announce it has awarded twentyseven (27) special one-time grants totaling \$24,000 from the Evie Scott Fund, the Verna Robertson Fund, the Miriam Newkirk Fund, the Maude Welch Fund, and the Nellie Kloeker Fund.

All recipients received their awards in the mail by March 5, 2021. In order to qualify for the grant funds, all organizations must have an Internal Revenue Service 501(c)(3) designation, and the funds must be used within the City of Seymour.

The following grants were awarded:

Actors Community Theatre of Seymour was awarded \$800 for production support equipment.

Anchor House was awarded \$800 for heavy duty totes.

ARC of Jackson County was awarded \$70.00 for a back-up hard drive.

Big Brothers Big Sisters was awarded \$750 for a new laptop and printer/scanner.

Central Christian Church was awarded \$800.00 to update the light fixtures in its auditorium.

Child Care Network was awarded \$799 to purchase a new paper shredder and dye-cut machine.

City of Seymour Parks & Rec Department was awarded \$500 for a new desktop computer.

Community Agency Building, Inc. was awarded \$750 for a new computer and software.

Community Provisions of Jackson County was awarded \$1,000 to be used towards the purchase of a new forklift.
